Braunschweig, the famous city founded by Henry the Lion, is located in the heart of Germany in Lower-Saxony. Although heavily destroyed during WW II, it offers remarkable historic substance, paired with the highest density of research institutes and organizations in Europe and a superb variety of musea.

The assembly will convene at the STEIGENBERGER Parkhotel, Nimesstraße 2, 38100 Braunschweig on Thursday, May 9, 2019 and will conclude on Sunday, May 12, 2019. The hotel will offer discounted room rates 3 days pre/post of the event.

Braunschweig is most easily accessible via *Hannover International Airport (HAJ)* and, with additional commuting time, via *Berlin – Tegel International Airport (TXL)*. It takes 50 minutes by car or train from HAJ to reach the hotel, approximately 2 hours and 20 minutes from TXL.

For those who like, Thursday morning begins with the traditional golf option. For the evening, we have arranged a Welcome Reception at our offices. The main event, however (besides the Business Session), will be IAG's splendid Black Tie - Birthday Party on Friday night. *The late night interest group shall also not have reason to complain ...*

As mentioned in Liechtenstein, we believe that IAG's extra subsidy for additional delegates' (including younger associates') attendance, the very reasonable hotel rate and its central location close to Braunschweig's downtown area will not only encourage the usual faces to show up in Braunschweig!
